**Old Business**

1. Church services during Advent and Christmas and New Years: dates and times

**New Business:**

1. Hymn Planning: Nancy Haese and Deb Welander met on Monday December 3. Pastor Steve will write up the Christmas Eve candlelight service with communion.
2. Special service plan for January 20<sup>th</sup>: Toni Groshek – “Life of Christ – a worship experience”. Cost is \$300.00. Will ask congregation for free will offering to pay for this. Pastor Steve will be out of town on that Sunday.
3. Budget discussion – looked at last year’s budget. Added items for music education, instrument repair, youth band expense, and guest musicians. Altar guild will be adding a line item in the budget for cleaning paraments, etc. Deb will prepare budget and send out at a later date for committee approval before submitting it to Vision Board.
4. Discussion of hired personnel: Deb proposed 2 items: paying for the choir accompanist and paying for the piano accompanists at the church services. Both were paid positions in the past at CTK. A lengthy discussion was held. Not all agreed on every item discussed. Dianne proposed that a separate fee for a person “in charge” for the contemporary service was also a consideration. Deb will write a separate proposal about all items that were discussed, send it off to the worship committee before sending onto the Personnel and Vision Board.

**Separate note:** (not discussed at meeting) I have asked Nancy Haese to co-chair this committee with me. The nomination committee will also be asking for other nominations. If you are interested in chairing or co-chairing this committee, please submit your name to the nomination committee.
