**Old Business**

-**Annual Meeting:** Committee feels we should go to one church service (9:00 AM, Meeting at 10:00 AM and no Sunday school, but children could go to a supervised activity, then potluck after that.)

**-Bulletin changes:**

1. We can eliminate the melodies inside the 8:15 bulletin, as long as we put the page number in there. We still would like to see the order of liturgy in the bulletin, but just replace the melody lines with page numbers (or hymn numbers such as offertory and Post-Communion hymn #).
2. After Easter (through August?) going to WOV for 8:15 am. We would like to have a “pamphlet” of just the WOV Setting 5 available for the melodies. Therefore we would not have to waste paper putting the melody in the bulletin all the time, yet parishioners at the 8:15 would still be able to see the melodic line for the WOV Setting.
